- Completed application form, with **all questions answered**, and **signed** at the bottom.
- Statement Essay Question** on a separate sheet of paper.
- A copy of your **2021 Federal Income Tax Return** (Form 1040, 1040A, or 1040EZ)
- A copy of all **W-2 forms** for 2021
- Copies of any **other proofs of income**, as needed.
- Copy of **two forms of identification** listing the primary address. Acceptable forms of identification are:
  - Driver's License
  - ID Card
  - Utility Bill
  - Lease
  - Pay Stub
  - Mortgage Statement
  - Local Tax Bill
